December 18, 2025

RESOLUTION NO. 500-25 APPOINT COUNTY LEGISLATOR

WHEREAS: District 3 Legislative position representing the Town of Owego will become vacant as of January 1, 2026 due to resignation of Legislator Barbara J. Roberts; and

WHEREAS: The term of office for Legislative District 3 runs until December 31, 2027;
and

WHEREAS: Pursuant to Local Law 3 of 2016, the vacancy may be filled by Legislative appointment by way of majority vote until such time as the office is filled as a result of a general election as provided by law; and

WHEREAS: The next upcoming general election is November 3, 2026; and

WHEREAS: The Legislature has found and determined that a qualified resident-electoral residing in the Town of Owego shall be appointed to discharge the duties

of District 3 Legislator until December 31, 2026 with the understanding that continued service is contingent upon the results of the November 3, 2026 general election; therefore be it

RESOLVED: That David Cantella is hereby appointed District 3 Legislator effective January 2, 2026 to discharge the duties of District 3 Legislator until December 31, 2026.

RESOLUTION NO. 501-25 *CREATE AND FILL A TEMPORARY PART-TIME
ASSISTANT PUBLIC DEFENDER POSITION
PUBLIC DEFENDER'S OFFICE*

WHEREAS: Legislative approval is required to create and fill a Management/Confidential position; and

WHEREAS: The Public Defender has had a vacant full-time position without applicants since April 2025; and

WHEREAS: The appointment of Michael L. Arcesi to the position of Public Defender as of January 1, 2026, has created an opening for a second full-time Assistant Public Defender position; and

WHEREAS: No applicants have been identified for either full-time Assistant Public Defender positions; and

WHEREAS: The Public Defender has determined that the office cannot meet its present requirements without at least one additional Assistant Public Defender; and

WHEREAS: The retiring Public Defender, Thomas R. Cline, is willing to accept limited part-time temporary appointment to cover some town and village court representation for the month of January 2026 only; therefore be it

RESOLVED: That one part-time Assistant Public Defender position shall be temporarily created and funded for the period of January 1, 2026, through January 31, 2026, at a salary of \$3,000, which will be paid out in payroll #2, and temporarily increasing the part-time headcount from 5 to 6; and be it further

RESOLVED: That the Public Defender is hereby authorized to appoint Thomas R. Cline to temporarily fill the part-time Assistant Public Defender position effective January 1, 2026; and be it further

RESOLVED: That this resolution will be null and void in the event that a suitable candidate for the full-time Assistant Public Defender position can be found and appointed in January 2026, and that this position will be abolished as of February 1, 2026.
