 - Plan is to be sent to the State by the end of October
- MAT Plan

Topic: Sheriff's Department – Shawn Nalepa

Discussion:

- Overdoses
 - 3 Opioid overdoses in July, 6 in August 2022
 - August 2021 had 9
 - Currently 2022 has had 25 overdoses
 - Total overdose for 2021 was 36
- Mat Program
 - Waiting for a CASA Trinity CASAC for program
 - Experiencing issues getting position filled
 - October 7th, 2022 program is to be implemented by law
- OD Maps
 - Trying to figure out discrepancy between what is coming through the county and what is input into the system.
 - PD not in compliance – Waverly has new chief coming in
 - Trying to get everyone on board
 - Dispatch is reaching out
 - Christina & Shawn met last Wednesday (9/7)
- Extreme Risk Protection Orders (ERPO)
 - New Law – different than the Safe Act
 - Search warrants required for MH subjects to take firearms from those at risk
 - Warrant allows thorough search of the house to take all firearms
 - Safe Act only allows firearms in plain view to be confiscated
 - A lot of questions on how this is to be handled
 - No guidance to date from the State
- CBH Issues
 - Jail contracted with CBH to provide a full time licensed Social Worker
 - Jail putting out another bid
 - Megan no longer works at the jail
 - May need help from Mental Hygiene with evaluations
 - Lori stated the department would be happy to help
