To Whom It May Concern:

As Chair of the Tioga County Legislature and on behalf of the Tioga County Shared Services Panel, I am presenting the Shared Services Plan for 2022.

Since the submission of our 2017 Shared Services Plan, the Panel of municipal officials representing our nine towns, and six villages continued to meet on a regular basis with good participation. In 2021, the Tioga County Shared Services Panel welcomed new member, Owego-Apalachin Central School District.

The Tioga County Shared Services 2022 Plan includes two projects:

Tioga County is partnering with Broome County for the project known as Broome County Purchasing Alliance (BCPA) for a Medicare Advantage Plan/Medicare Part D Prescription Drug Coverage for the County's eligible Medicare retirees and their spouses. This partnership was made possible through a Request for Proposal with Broome County who chose United Health Care as the vendor. The Tioga County Legislature adopted a resolution on September 16, 2021 authorizing a contract with United Health Care to proceed with new plan effective January 1, 2022. This plan will realize an estimated cost-savings of \$770,000.

Owego-Apalachin Central School District is partnering with Capital Region BOCES for a prescription drug plan known as NYS Pharmacy Purchasing Coalition noting the partnership was made possible by the school district joining their Pharmacy Purchasing Coalition effective January 1, 2022. This plan will realize an estimated cost-savings of \$275,000.

The Panel conducted the required public hearings on both projects and there was no public opposition.

By my signature below, I hereby certify these two projects are the basis of the Tioga County Shared Services Plan for 2022 to identify savings to Tioga County and the Owego-Apalachin Central School District, as well as the respective partners.

In addition, we conducted three public hearings on October 25th with local media and one resident present.

In August 2021, Tioga County became aware of a shared services opportunity with the Broome County Purchasing Alliance (BCPA) for a Medicare Advantage Plan/Medicare Part D Prescription Drug Coverage for the County's eligible Medicare retirees and their spouses. The Legislature proceeded with the adoption of a resolution at their September 16, 2021 Legislature meeting authorizing a contract with the chosen vendor, United Health Care effective January 1, 2022.

In September 2021, Tioga County was approached by the Owego-Apalachin Central School District to join the Tioga County Shared Services Panel, as they were interested in pursuing a shared service opportunity for a prescription drug plan and management through their school district and Capital Region BOCES effective January 1, 2022 for inclusion in the 2022 Tioga County Shared Services Plan.

At the October 20, 2021 Shared Services Panel meeting, we welcomed and accepted the Owego-Apalachin Central School District as our newest Panel member. At this meeting, the Owego-Apalachin Central School District and Tioga County presented their proposed plans for inclusion in the Tioga County's 2022 Shared Services Plan.
